

2010 Kentucky Horse Breeders Incentive Fund

The funds allocated to the RMHA participants in the KHBIF have recently been released by the Kentucky Racing Commission. The amount that will be distributed to Rocky Mountain owners for the 2010 program is \$45,664.

Based on the program submitted to the Racing Commission for the three-year cycle ending with the 2011 season, this amount will be equally divided between the participants in the sanctioned show program and the rated trail program.

All horses participating in the KHBIF program must be nominated by their owners. The form may be downloaded from the RMHA website, and is necessary for verification that the horse named was born and bred in Kentucky.

The computation of the awards was based on the total number of points awarded to KHBIF nominated horses divided into the amount of money provided. For 2010 this amounted to \$3 for each point. This amount was then divided with 80% to the participating horse, and 10% to both the sire and dam of that horse. Since the funds may only be awarded to current RMHA members in good standing, the money which would have gone to ineligible owners was put back in the pool and divided equally among the winners. The points earned by the winning horse varied from class to class, and the amount paid out necessarily varied also.

The funds allocated to the Rated Trail Program were divided equally between the Gold and Silver Divisions: one half was split among the 8 winners of Gold Certificates, and one half was split among the 14 winners of the Silver Certificates. Additionally, the money that would have been paid to ineligible owners was returned to the pool and split among the recipients.
